



# Buckeye Morgan Horse Sale LLC

Dear Friends,

We are accepting consignments of Registered Morgan horses for the 21<sup>st</sup> Annual Buckeye Morgan Horse Sale, to be held **March 22 & 23, 2024** at the Ashland County Fairgrounds, 2042 Claremont Ave., Ashland, OH 44805. Consignments will be accepted until **Jan. 15, 2024 or until full**. Please send your consignments to Steven Yoder, 13101 Berg Road, Apple Creek, OH 44606.

We will be selling horses 2 days: Friday, March 22 and Saturday, March 23, 2024.

The commission fee for each horse consigned will be eight (8%) of the first \$10,000, six (6%) of the balance over \$10,000 and up to \$20,000, and two (2%) of the balance over \$20,000 with a minimum fee of \$100.00. The consignor will have the privilege to no sale (Pass Out) his horse. If the horse is passed out, the cost to the consignor will follow the commission scale above off the highest bid with a minimum fee of \$100.00 per horse.

ALL horses must be registered with the American Morgan Horse Association or the Canadian Morgan Horse Registry and all registrations must be in current owner's name and the owner shall sign the transfer before any monies are transferred to the consignor. If a registration is pending, a letter must accompany your consignment form. If a mare is in foal, that foal or any foal by her side must be eligible to be registered with AMHA or the Canadian Morgan Horse Registry. The sale committee will be inspecting horses; however, the owner's statement of soundness will be announced from the auction block. The sale committee reserves the right to reject any horses for any reason including, but not limited to unsoundness, poor physical condition, improper documentation of health requirements or incomplete registrations.

If a horse becomes unable to sell because of death or sickness a substitute may be used, but the sale committee MUST be informed of the change immediately and approved by the committee. A Vet certificate of death, illness, or unsoundness must accompany the request. If a horse is sold or the owner is unable to make a substitution before the sale day a fee of \$200.00 per horse must be paid.

All horses must have a negative Coggins test within 6 months of the sale (AGID, ELISA, or a quick test will allow entry into Canada) and health papers within 30 days of the sale. Tetanus, Flu, and Rhino shots are required to be administered and documented before the sale. If international health papers are needed, go to website [www.aphis.usda.gov](http://www.aphis.usda.gov) or call Vet services in Pickerington, OH 614-856-4735 for any questions.

Mares sold in foal, if questionable must be checked at the buyer's expense before leaving the fairgrounds. If found not to be in foal, it will be at the seller's expense. All bred mares or mares

that have foals by their side at sale time MUST have a signed registration application with Stallion information.

We will sell in order as printed in the catalog. If you want a pair of horses to sell together, you must inform us when you send in your consignment. If you do not, we will not be able to change the order to sell them together.

All "NO SHOWS" will be charged a \$200.00 fee per horse, unless a vet certificate of unsoundness, sickness, or death is received by the sale committee. Any outstanding fees will prohibit you from selling a horse until the debt is paid.

All consignments must include a **clear and readable** copy of the horse's registration papers and a completed and signed consignment form along with the consignment fee of \$100.00 (US funds) per horse. Please include all information regarding registration and footnotes that you want in the catalog. Any information that is sent after the deadline will not be guaranteed in the catalog. The consignment fee is non-refundable. Please make your check out to Buckeye Morgan Horse Sale. If checks are returned NSF, there will be a \$30.00 fee. No consignment will be accepted without the consignment fee included. If you want a photo in the catalog, it must be camera ready. Please make sure when sending any information (paperwork, pictures, etc.) to the office via mail or email, all information is marked with the consigned horses name and consignor.

If you consign to the sale, you will receive a catalog when they become available.
